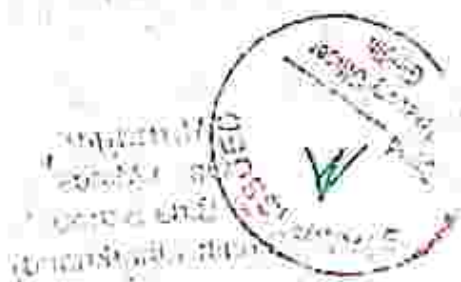

AND WHEREAS THE SETTLOR above named has settled a sum of Rs. 10000/- (Rupees Ten Thousand only) as a fund in favour of the TRUSTEES upon Trust with a view to give effect to his desire of creating and establishing a Trust for the purpose of establishing educational, medical and charitable institutions.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:


1. NAME OF THE TRUST :-

The Trust hereby established shall be named as "BARKAT ARA EDUCATIONAL TRUST"

2. PROPERTY OF TRUST :-

The trust properties shall consists of

- a. The amount transferred by the SETTLOR as mentioned above, towards the Corpus Fund of the Trust i.e. Rs. 10000/- (Rs. Ten Thousand only).
- b. Any cash or kind, properties, movable and immovable that may be acquired by purchase or otherwise or all manner of rights, title or interest in or over my property movable or immovable.

- c. All additions and accretions to the Trust properties and the income there from
- d. All donations, gifts, legacies or grants, in cash or kind accepted by the Trustees upon trust.

The properties of the Trust shall be utilized for the objects set forth herein above and subject to the provisions and conditions herein mentioned.

3. REGISTERD OFFICE :-

The registered office of the trust will be located at Dharindih, Thana- Giridih (Town), Block- Giridih, District- Giridih (Jharkhand) or at such other place as the trustees may decide from time to time.

4. BENEFICIARIES OF THE TRUST :-

The trust is established for benefit for the humanity as all and the class of people mention above without discrimination of caste, religion, creed or sex.

5. AIM AND OBJECTS:-

MAIN OBJECTS

- (a) To construct and run schools, colleges, hospitals and educational & medical institutions for the benefit of the public-at large and/or to open residential public school, the name will be decided after mutual understanding of Trustees.
- (b) To provide grants, scholarships, fellowships and other forms of financial assistance to the needy and deserving students for pursuing educational, vocational training, skill development etc.
- (c) To grant financial assistance to any educational institution for granting scholarships, prizes, medals, awards for excellence in studies, sports and scientific research, distribution of books and note books for poor and or deserving students.
- (d) To provide necessary facilities or to contribute to educational and scientific research development in any place as the trust finds deemed fit.
- (e) To carry out any activities with the intension of services but not of any profit making.

- (f) To print, publish, purchase, sell, circulate, distribute or exhibit either free or for a price-books, periodicals, journals, booklets, bulletins, calendars, message-cards, other literature, films, documentaries, records, paintings and photographs which will assist or promote the objects of the Trusts.
- (g) To purchase, sell or otherwise distribute materials and services in the furtherance of the objectives of the Trusts.
- (h) To arrange and organize lectures, debates, discussions, study tours, conferences, or radio-talks for the advancement of the objects of the Trust.
- (i) To organize and run residential educational programme.
- (j) To establish Training Centre and allied educational institutions.
- (k) To organize and run School under the affiliation and recognition of CBSE, and/or other Central, State Board and non-governmental agencies within India
- (l) Raise funds through donations and contributions to support all the above activities, and setting up appropriate management structure, including subsidiary units as necessary.
- (m) Create assets and transport facilities to accommodate any of the above activities.

OTHER OBJECTS

- (a) To create awareness on various social, moral and economic issues affecting the country and to direct this awareness in developing innovative means of generating resources-financial, material and professional and channelize these resources through people and projects in the fields.
- (b) To promote national integration and encourage, support and develop social welfare program for balance growth of the nation.
- (c) To provide financial or any other assistance towards relief and rehabilitation of the populace affected by calamities like cyclones, earthquakes, epidemics, fire, famine, floods, war, riots etc.
- (d) To establish, maintain or support a home or homes for widows, orphans, special centre for providing shelter and protection to women and children in distress.
- (e) To create and promote enlightened public opinion on various issues affecting the citizens of India.
- (f) To encourage conservation, afforestations and protection of the environment including birds, animals and all species of plants and animals.

- (i) To accept, in cash or kind, donations, gifts, grants, contributions, (as corpus or otherwise) and to collect interest and other income of the Trust for being utilized for furtherance of the aims and objectives of the trust.
- (ii) To purchase or to take on lease lands, buildings and other immovable or movable properties in the name of the Trust.
- (iii) To invest, dispose of, transfer and otherwise deal with monies, assets and properties, for the time being, of the Trust in such manner as the law permits and proper to do in carrying out the aims and objects of the Trust.
- (iv) To pay all expenses preliminary or incidental to the formation of the trust and its registration and for management and administration for the same.
- (v) To do all such acts, deeds and things and extend all such other assistance to the said voluntary organizations as may be necessary and incidental to the attainment of aforesaid objects.
- (vi) All activities financed from the fund shall be conducted in accordance with the ideas and objects as stated hereinabove and no discrimination shall be made on ground of religion, caste, creed, sex or politician affiliation of the implementing agency of beneficiary.
- (vii) Advancement of any other objects of general public utility which may qualify for exemption under the provision of Income Tax Act, 1961.

6. BOARD OF THE TRUSTEES, THEIR TERM AND POWER TO CO-OPT:-

- a. The management and control of the Trust and the Trust properties shall vest in the Board of Trustees which shall comprise of not less than four and not more than eleven Trustees.
- b. The parties of the Second Part including the settler will be the First Trustees and they shall automatically form the Board of Trustees.
- c. The annual meeting of the Board shall be once of each year. The Board may also meet on requisition by any Trustee. All decisions of the Board shall be by simple majority unless otherwise provided.
- d. Any trustee may if he/she do desires, resign his/her trusteeship and the resignation would be effected only from the date of acceptance of such resignation or six month, whichever is earlier, by the Board of Trustees.
- e. The tenure of the Trustees shall be for the period which shall be decided by the Board of Trustees as they may deem fit.

f. The office of a Trustee will automatically become vacant on the occurring of any of the following events:

- (1) Death of Trustee (2) Bankruptcy of the Trustee (3) conviction of the trustee for a criminal offence under the Indian Penal Code.

g. The Board of Trustees shall nominate Managing Trustee/Trustees from time to time which shall essentially be a member of the board of trustee.

h. Sri Arman Ahmad and Smt. Shefali Eara has jointly been appointed as the first Managing Trustee and shall be designated as "DIRECTORS" till such time and period, Board in its validly convened meeting, does not replaces any new trustee as such.

7. APPOINTMENT OF NEW TRUSTEE/FILLING UP OF VACANCY:-

Subject to the provision contained in Clause 6 mentioned above, the appointment of new Trustees shall be government by the rules as follows:

a. After the completions of the tenure of office of the Trustees as may have been decided by the board of trustees, they shall retire but shall be eligible for re-appointment.

b. In case of vacancy/vacancies, new Trustees shall be appointed from among the Public, representatives of voluntary organizations, funding agencies and independent expert in the field of development, finance, legal and other related matters or as the board of trustees may deem fit.

c. Filling in of vacancies shall be by a decision of the Board of Trustees. As far as possible, efforts shall be made to fill in, the vacancies by unanimous decisions failing which the majority decision shall prevail.

d. If and as often as the trustees of THESE PRESENTS shall die or desire to retire or refuse or become incapable to act in the Trust thereof shall take the benefit of the insolvency law for the time being in force or if any Trustee shall remain absent from six consecutive meetings of the Trustees without leave of absence, then and in every such case, it shall be lawful for the surviving or continuing trustee or trustees for the time being of THESE PRESENTS to appointment new trustee so vacating their offices in the Board of Trustees.

e. On death or any casual vacancy of the trustee, remaining trustee shall within a period of 12 months from the date of such vacancy, elect a new trustee in his place as per provision set out in this deed. Till such time it shall be lawful that the surviving or continuing trustee shall be entitled to carry on the objects of the trust, till the vacancy is filled up.

8. EFFECT OF APPOINTMENT OF NEW TRUSTEES:-

Upon every such appointment made in pursuance of the last foregoing clauses thereof, the newly appointed Trustees shall have power and authorities of a Trustee under THESE PRESENTS.

9. TRUST ADMINISTRATION AND POWER TO THE BOARD:-

- A. The Board of Trustees Shall have power to:
 - n. To administer the Trust, its properties and affair and do all the things which will fulfil the performance of the objects for which the Trust is established and for this purpose the Board can apply the whole or any part of the Trust property towards the payment of the expenses of the Trust.
 - h. The Board of trustees shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think fit and proper, to appoint Committee to function under the Authority and Control of the Trustees for carrying out the objects of the trust of these presents or the management thereof and invest them with all such power including power to incur all such expenditure as may be necessary for carrying out the objects of the Trust.
 - c. To open one or more bank accounts and operate the same or provide for operation of the said accounts by any two among them authorized on their behalf.
 - d. To Invest the Trust Funds in the Manner not prohibited by any provisions of the Income Tax act, 18961.
 - e. To buy, sell mortgage, grant, lease, hire or otherwise alienate all or any of the properties of the Trust in its discretion for adequate consideration.
 - f. To execute power of attorney or powers of attorney to any person for the purpose of executing, administering or managing the whole or any part of the Trust for the purpose of all or some among the objects of the Trust.
 - g. To borrow money with or without security and to repay the same.
 - h. To receive, collect and enforce recovery of all monies due or payable to the Trust and grant receipts and discharge therefore.
 - i. To settle, compromise or compound any disputes or refer the same to arbitration or litigation.

- j. To receive voluntary contributions from any person or persons, any organization, association, trust and NGO from India or outside, after complying with the statutory formalities, by way of donation, gifts or in any other manner and to hold the same upon Trust for the objects set forth herein.
- k. To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the Trust, to frame rules relating to their salaries and other benefits and generally to exercise all power ancillary and incidental to effectively carry out the objects of the Trust.
- l. The Board shall have power to make and rescind rules and regulations for the management and administration of the Trust.
- m. No Trustee shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund/property.
- n. The Board of Trustees will follow the instruction given by any donor who makes substantial contribution toward furtherance of the objects of the Trust, so long as such instructions are not detrimental to the attainment of the objects of the Trust and are in conformity with the provisions of the Income Tax Act, 1961.

B. ROLES AND RESPONSIBILITIES AND POWERS OF MANAGING TRUSTEES:

The Roles, Responsibilities and Power of all these managing trustees as office bearers are defined below. In addition to these, the Board of Trustee may grant additional roles, responsibilities and power to any of the Trustees as and when required

In addition to discharging normal duties of a trustee, the Managing Trustees, designated as "DIRECTORS" will be authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreement with individuals, government institutions and other organizations on behalf of the Board of Trustees upon the decision of the Board for each and every case.

The managing trustee is authorized to sign along with the treasurer bank cheques, deposits release voucher etc

The Managing Trustee along with the Board of trustees is responsible for ensuring that the Trust pursues its objects and for maintaining the dignity of the Trust organization and shall use his/her influence to promote the activities of the Trust.

10. MEETING OF THE BOARD OF TRUSTEES:-

The Board of the Trustees should meet at least once in every calendar year and may meet more often when required.

- a. The meeting of Board of Trustees shall be convened by the Chairman of the meeting. Any member of the Board of the Trustees can call for a meeting.
- b. One half of the Board of Trustees or a minimum of three trustees, whichever is higher, shall constitute the QUORUM for the Board of Trustees meetings
- c. All decisions shall be carried out by the majority decision of the Board but in the event of equality of votes, the chairman presiding over the meeting shall have a casting vote.
- d. Any resolution in writing signed by all the Trustees by circulation shall have equal force as through it has been passed at a meeting of the Board of Trustees.
- e. The meeting of the Board shall be convened after giving at least a week's notice unless all the Trustees agree to accept a shorter notice.
- f. The Board of Trustees may invite other persons interested in the objects and functioning of the Trust to attend the meeting of the Board, but they shall not be entitled vote in the meetings of the Board.

11. BANK ACCOUNT:-

The managing trustees may jointly open any banking account or accounts with such scheduled bank as may from time to time be determined by them and shall forthwith pay or cause to be paid the rents, income, dividends and all other money forming part of the Trust Fund to the credit of any such account or accounts and such account or accounts shall be operated upon by such managing trustees or other persons as may from time to time be authorized to do so by resolution of the Board of Trustees.

12. INVESTMENT OF TRUST FUNDS:-

All money forming part of the Trust Fund and requiring investment shall be invested in any of the securities authorized by law for investment of Trust Funds which are permissible under section 11 (5) of the Income Tax Act, 1961 or shall at their discretion sell and/or realize the same or any part thereof.

All money forming part of the Trust Fund requiring investment shall be invested and the conveyance of assurance in respect of any immovable property/ properties forming part of the Trust fund shall be obtained in the name/ names of the Trustee/trustees for time being of the Board of Trustees.

13. RECEIPT OF THE TRUSTEES:-

The receipts in writing by the Managing Trustee or any other person authorized by the Board of Trustees for any interest, dividend or income of the Trust Fund or for any deeds, papers, writing documents or other monies and effect payable to the Trustees shall be sufficient and effectual discharge for the same. The Board of Trustees by a resolution may also authorize any scheduled bank or other banks in India to collect any interest, dividend or income of the Trust Fund on their behalf.

14. ACCOUNTS AND AUDIT:-

- a. The financial year of the Trust shall be closed on 31st March every year, unless otherwise decided by the Board of Trustees.
- b. The Board of Trustees shall maintain true and correct accounts of the Trust.
- c. The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and all matters in respect thereof in the course of the management of trust properties or in relation to carrying out the objects and purposes of the trust as well as of all the assets, liabilities, credits and effected of the trust properties.
- d. The accounts of the Trust shall be annually audited by a Chartered Accountants appointed by the Board of Trustees and the Audit Statement of account shall be placed before the Board for its approval within three months of the close of the financial year.

15. AMENDMENT:-

While this Trust shall be irrevocable, the Board of trustees may amend any of the clause except those relating to object of the Trust. The first Trustees, at a duly convened meeting of the Board with at least 2 weeks' notice, and by a resolution passed by at least three-fourth majority of the Board of Trustees. The amendments of the Trust deed can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation.

16. INDEMNITY:-

The Trustees for the Time being of "THESE PRESENTS" shall be chargeable only for such monies, stocks, funds, deposits and securities as they shall actually receive, notwithstanding their signing of any receipt for the sake of conformity and shall be answerable or accountable only their own acts, receipts, neglects, defaults, and not for those of other or any banker, auctioneer or any other persons with whom or into whose hands any Trust monies or securities may be deposited in accordance with "THESE PRESENTS" nor for the determination or loss of any stocks, funds, depositors securities nor for any defects or insufficiency of title nor for any other losses unless the same shall happen through their own neglect or willful demeanor. - b. Any "related concern" in which any of the above persons has substantial interest.
- c. For the purpose of this clause the word "relative" and the phrases "related concern", "substantial interest" and "substantial contribution" shall have the meaning assigned to them in the Income Tax Act, 1961.

All clause herein are intended to secure exemption from Income Tax on the income of contributions and donations to the Trust and any clause or portion of this Deed of Trust which is inconsistent with or repugnant to the sections of the Income Tax Act, 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.

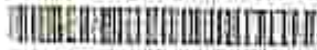


